## SFA and ICCAW create a new partnership to promote sustainable cashmere in China

The SFA is proud to announce that we have signed a Memorandum of Understanding with the International Cooperation Committee on Animal Welfare (ICCAW) to cooperate in the development and implementation of a joint Code of Practice for the accreditation of environmentally sustainable and high welfare cashmere in China. The Code of Practice will provide specific guidance for herding families and companies on how to implement ICCAW's Cashmere Goat Farm Animal Welfare Requirements and will sit within the SFA Cashmere Standard.

The SFA is a leading international NGO promoting cashmere sustainability with more than 40 members from international manufacturers, brands and retailers. They have been implementing the SFA Cashmere Standard in Mongolia since 2015. ICCAW is China's leading non-profit organisation in the promotion of animal welfare standards since 2013 and has more than 200 core members. This partnership brings together the strengths of both organisations, providing the increasingly sustainability-conscious cashmere industry with a robust approach for assuring animal welfare and environmental sustainability on their supplier farms. Our partnership will enable both Chinese and international companies to provide practical support to their suppliers at the grassroots level, obtain credible evidence that on-farm management practices meet international standards, and link supply and demand for sustainable cashmere.
